6-CHAIRPERSON'S REMARKS & APPRECIATION

It is great to be back together again in person for our AGM, welcome to those of you watching on zoom, the more participants the better for this meeting.

2022 saw our return to in person services, we have had a steady number of congregants return to our sanctuary for Sunday services and we continue to have a loyal group who attend online.

In 2022 we were even able to hold a few in person events. The Easter Breakfast was our first, we were so excited to have almost the same number of people attend breakfast last year as we did the year prior to the COVID shut down. Then we had the Harvest Supper and the bazaar. It was interesting because although we didn't seem to have as much merchandise or shoppers as we have had some years, the sales were good, and we were very pleased with the results.

Being able to hold these events is important for many reasons, the most obvious reason is their financial contributions to our church but almost more importantly their contribution to our fellowship and community spirit. Although they are often hard work, the time we spend side by side working on a common project provides us with so much more than just the funds raised.... Bonds are created, friendships made, and community spirit is built, the value of these things are immeasurable.

Last year we were able to finish paying off the loan from Regional Council that we had taken out to repair the roof over the auditorium. They have asked me to share the following letter with you.

Letter from Regional Council was read.

This is quite an accomplishment, and we thank all who pledged and honoured their pledges. However, we cannot sit on our laurels and think that all is well now that the roof is paid off. Over the years the building continues to age and repairs continue to creep up. Many of you will have noticed a new leak in the parlour, that will need attention this spring, and our kitchen is going to be needing some big time TLC in the very near future. We would like to upgrade some of the technology in the sanctuary in order to be able to better accommodate our online and in person service requirements, as well as to make the sanctuary perhaps a more attractive venue to be able to use it of more outside events, generating some additional rentals.

We are just holding on financially, we are grateful for the regular income from our tenants, we would be in serious financial difficulty without their revenue. Thank you to all our members who contribute on PAR, as this enables Bev, our treasurer to be able to budget with some accuracy what will be coming in in donations. I would encourage everybody to join in on PAR, you could see Bev for a form, if you would like to join up. If you are already on PAR and at all able to, have a look to see when the last time was you increased your donations and If that is a possibility at this time. I know for myself I just forget about the donation and if not reminded from time to time, it is very easy to forget to make any changes.

I would like to take this time to thank all the council members who continue to work behind the scenes to keep things going. An extra thank you to the members of M&P who continue to fill in for the work normally done by an office administrator.

It is very important that we acknowledge our staff members at RUC.

Don Jackson, our caretaker, he isn't here right now. He comes in early on Sunday to open the building and make sure everything is Ok and then heads off to see his mother where she lives and keep her company for her mealtime. Don knows this building like the back of his hand and takes care of it as if it was his own. He is very mindful of extra costs and tries to make every penny count if something needs to be purchased. Thank you, Don, for your dedication and devotion.

Darryl: What can I say that we haven't already said. We are so lucky to have you as our minister. You are a visionary; you keep us looking forward and not just looking back on what has always been done or staying stuck in our ways. You feed our spirits and encourage us to be the best we can be as people, as members of this congregation and members of our community.

Dear Friends,

In Paul's letter to the Ephesians that is quoted above, we find a path for us to walk in our secular society. We are not to convert others to our church, but, rather, we are to be servants to the Good News of Jesus, so that others can witness God's wisdom in our community through our actions. And, we are to be bold and confident in our faith, which is the gift bestowed on us through Christ. In other words, we are to be a community that centers itself in the sacred, and that promotes the sacred in ourselves, others and in the very fabric of creation. The Good News is that God dwells with us and walks with us.

Being aware of our sacredness is not something that comes naturally to us. We tend to live more in the negative; being frustrated, afraid and uncertain. The discipline of being aware of the sacred is low on our priority list, if it is there at all. We see ourselves as anything but sacred. This can and does affect our sense of community. We see our church as a shrinking shadow of its former self and wonder how long we have. It is like there is a veil over our future. But aren't you at all curious as to what's beyond the veil? I certainly am, so let's lift the veil of the shadow and see what's underneath and beyond. Let us not worry about flaws or faults we may find; rest assured, we will find them. Let us not worry that we are not perfect, for God does not care much for perfection. God cares for us and loves us as we are here and now. So what is under the veil is really ourselves, working as best we can to live out God's call to be the sacred beings we are made to be.

As we head into 2024, I must extend my thanks for all who put their awareness of the sacred on their priority list; whether you attend in person or online. I am thankful for those who work on the committees of our church. Your dedication and devotion are commendable. Thank you to all who contribute their time, talents and finances, and to Bev Baker for her hard work of keeping the books. Thanks to Don for keeping our building clean and property maintained. Thanks to Sandy and the "Band" for leading us in music. Thanks to the Council for continuing to hold us together. And thanks to our neighbouring United Churches who join with us and expand our worship experiences.

Let's make the year to come one in which we move with the Spirit of God to celebrate the sacredness within and all around us, so that through us, the wisdom of God in its rich variety might now be made known to the rulers and authorities in the heavenly places.

As I read through the minutes of the Regional Council from 2023, I found the following that might be of interest:

A list of grants to churches one of which resulted in an excellent series of trainings which I happened to attend along with Lynda Scardocchio and Janet Herridge. Our minister Darryl Macdonald is chair of the Family Life Centre and they applied for a grant from the Erskine-American – Mountainside Fund to hold 3 sessions for our Pastoral Care teams in our Riverside and West Island United Churches Cluster. This is an example of how our regional council can help improve our visits to our church members.

After spending many years finishing the translation of the Bible into the Mohawk language, Harvey Satewas Gabriel has paid tribute to all the others who had already translated parts of the Bible. The Nakonha:ka Regional Council contributed towards the publication as did the Kanesatake United Church and the Kanesatake Mohawk Council and other organizations. It is now for sale at the United Church bookroom.

In June our regional council executive minister Eric Hebert-Daly issued a statement standing against the rise in homophobia and transphobia in our society and the idea that children need to be "protected" from the LGBTQ2+ community.

Also in June at our annual meeting the following three wonderful persons were ordained as ministers of the United Church of Canada: Cynthia Reynolds, Aron Molnar and Aaron Miechkota.

At our fall meeting we heard the results of a Strategic Plan in which many members of our regional council had input. The plan was based on three readings from scripture. In Genesis 18: 2, 3-19 Sarah just knows that she could never have a baby at her age but God sees something possible. We might think our churches don't have a future but God reminds us that we do have a future even if we see an overwhelming decline. In John 6: 5-13 the disciples know that there is not enough food to feed 5000 people but a small boy offers all that he has – 5 loaves of bread and 2 fish and everyone receives plenty to eat. In our regional council, we have what we need to grow our church.

In 2 Corinthians 3: 12 Paul reminds us "Since, then, we have such a hope, we act with great boldness." Let us have faith and act boldly!

Family Life Centre

The Family Life Centre is a non-profit community resource supported by seven West Island churches, including Roxboro United Church. It offers resource information and workshop sessions on issues affecting families, couples and individuals.

Again in 2023, the Family Life Centre (FLC) offered several information sessions on Zoom in its ongoing "Demystifying ..." series. They were very popular and provided helpful information on various topics.

The FLC Coordinator continued to monitor and respond to social media requests for referrals to local resources and kept the FLC website updated with useful info for clergy and church members' use.

The FLC also organized and hosted a comprehensive Pastoral Care Team Training in the Fall of 2023. Clergy of Family Life Centre supporting churches were polled for their Wish List of training topics because much has changed since the last Pastoral Care Team training 5 years ago. Having the FLC Coordinator organize the training benefited the pastors and staff of the 6 supporting congregations. It saved them from having to spend valuable time and energy studying new trends, researching and creating an agenda, booking presenters and advertising the series. Equipping church members with new ways to support one another will be very beneficial to each congregation.

To maximize convenience for participants and to engage facilitators with extensive knowledge and lived experience in the chosen topics from across Canada, the training sessions were on Zoom. The training covered doing pastoral care visits in various venues and circumstances, what to say (and what not to), walking the grief journey with someone, cultural differences in our changing demographic, new expectations on how to give and receive care post-pandemic, pitfalls and benefits of social media in pastoral care, how to pray with and for someone, boundaries and self-care, and ways to offer practical help in acute and ongoing situations. It was a very enlightening programme. There was no registration fee for participants from FLC supporting churches as the administrative costs, presenters' honoraria and cost of the Zoom account were covered by the \$400 annual support contribution and a grant from the Erskine American and Mountainside Trust.

Trustees

The role of the Trustees is summarized from the Manual 2022 G.3.1 to G.3.3.4 as follows:

The congregation is responsible for having a board of trustees for the congregation.

The congregation is responsible for appointing the trustees at a congregational meeting.

A majority of the trustees must be members of the United Church.

One of the following people is automatically a trustee because of their position:

- a) the member (or one of the members) of the order of ministry who has been called or appointed to the pastoral charge;
- b) the designated lay minister who has been recognized by the regional council and appointed to the pastoral charge; or
- c) the pastoral charge supervisor.

The congregation is responsible for deciding on the number of its trustees. There must be a minimum of three and a maximum of 15, including the one person who is automatically a trustee.

This year the Trustees dealt with the specific needs of the church through emails and Zoom meetings. We even were able to meet in person one Sunday following worship. Mostly these meetings dealt with building maintenance issues. We also made sure the new contracts were written up with returning renters like NOVA, dog training, AA groups and ongoing renters like Pierrefonds Community Project and West Island Seventh Day Adventists. François and his team repaired the roof over the Parlour and Kitchen and we hope that the mended seams hold through the winter and spring melt. We are thankful that Donald Jackson continues to take great care of our building and makes life easy for our renters and a pleasure for us to come in each week and use the building.

As we continue to open up let's look forward to 2024 and to building our community.
